I. Call to Order and Roll Call

The Chair called the meeting to order at 9:02 a.m. and asked the clerk to take the roll. A quorum was present, and absent members were excused.

II. Approval of April 4, 2018 CJPC Meeting Minutes

The Chair asked members if there were any corrections to the proposed April 4, 2018 CJPC meeting minutes. There were none. Commissioner Verheek moved, supported by Commissioner Kaminski, to approve the minutes of the April 4, 2018 meeting as proposed. There was no further discussion. The minutes were approved by unanimous consent.

III. Data Subcommittee Update

The Chair began by asking members to keep in mind that the current analysis will focus on one grid only and other areas may be added if there is time. He then called on CJPC Data Administrator Grady Bridges who provided a recap of the latest discussion by the Data Subcommittee on the Commission's goals, He then proceeded with an explanation of the list of variables and data sets available (see attached for more details). Questions and comments from Commissioners were made throughout Mr. Bridges' presentation. Commissioner Kaminski inquired if there is sufficient data in the data set if status offense "none" is only used. Mr. Bridges responded that he believes there are enough observations in that category to make statistically significant conclusions and he expects the number of observations may increase when 2017 data from MDOC is included. Commissioner Kubiak pointed out that the question of sample size may become more complex depending on how the observations straddle and if they are broken down by SCAO region or county. Commissioner Levine noted the issues of not including certain data sets and looking at county size as a dividing factor. Commissioner Verheek urged caution when comparing the differences in sentencing patterns in Kent County with other large counties on the east side. Senator Colbeck asked questions to clarify the context of the data sources and suggested more unique visualization tools be added. Commissioner Kubiak suggested, in terms of scoring, it may be easier to follow if we begin with a very simple model and then add different variables to build upon that base model. A discussion and explanation of the sentencing quideline scoring variables available followed. Commissioner Strange commented that mental health data needs to be looked at even with its limitations of being self-reported. The Chair and Commissioner Levine agreed. Commissioner Levine expressed her concern with COMPAS scores and Mr. Bridges explained that he does not have COMPAS scores in the current data set, but he could look in to acquiring this information from the Department. Commissioner Verheek added that he does not think the COMPAS material would be available for the data set the Commission is working with since it has only recently been made available. Judge Stutesman clarified that COMPAS has been completed by the agents for years and it has only been since 2017 that COMPAS became part of the pre-sentencing report and is used to identify the needs of the offender and the programs he or she is eligible to receive. At the next meeting, Mr. Bridges will provide reports that include figures of areas where there are discrepancies and the contributing factors that are statistically significant. The Chair asked members to let Mr. Bridges know within one week any additional factors they Final CJPC Meeting Minutes May 2, 2018 Page 2

think need to be considered. Mr. Bridges shared that the objectives of the next meeting will be to review the results of his analysis and the statistically significant factors for Research Question #2 and move forward on Research Question #3. Judge Stutesman requested members receive the projected reports and charts the Friday before to allow ample time to review before the next meeting.

CJPC Pilot Study Overview Sentencing Guidelines and Straddle Cell Sentencing

1. Study Goals:

Using data made available by the Michigan Department of Corrections our analysis seeks to provide answers to the following questions:

Research Question 1: To what extent are prison sentences, relative to intermediate sanctions, imposed on those who score in straddle cells on the D -Grid?

Research Question 2: For offenders with similar offense and offender characteristics, are there disparities in the rate of prison sentences? If so, what factors or characteristics are contributing to such disparities?

Research Question 3: Does the recidivism rate for those receiving a prison sentences differ significantly from those receiving intermediate sanctions?

2. Data Collection

The MDOC provided the commission with two datasets containing felony sentencing information from Jan. 1st, 2012 through Dec. 31st, 2016:

- a. BIR DEM contains demographic data associated with the sentencing event. There
 will be one record for each sentencing event (combinations of offender, sentence date,
 and sentencing county).
- b. BIR OFF the offense portion associated with the sentencing event. There could be multiple offense records for each sentencing event each potentially with their own sentencing guidelines and sentences.

3. Scope of Analysis

As discussed by the commission, the analysis in this study will focus on individuals sentenced between Jan. 1st, 2012 and Dec. 31st, 2016 and score within a straddle cell for Class D felony offenses. Furthermore, habitual offenders and those with probation violations will be excluded while considering the initial sentencing decision.
