# I. Call to Order

Chair Ronayne Krause called the meeting to order at 3:30 p.m.

## II. Roll Call

The Chair asked the clerk to take the roll. Judge Dobrich joined later at 3:36 p.m.

## III. New Meeting Time

The Chair noted based off discussion at the April 12, 2022 meeting a survey was conducted amongst committee members that resulted in the majority of members in favor of a 3:30 p.m. meeting time. - e. Legislative Subcommittee:

Ms. Cannon was not present at today's meeting. The Chair called on Judge Hoffman for an update. Judge Hoffman discussed HB-5512 was sent to the Governor's desk for signature. Judge Hoffman updated that none of the other bills discussed in detail at previous meetings have moved and MATCP will continue to support these bills going forward.

Mr. Smith expressed optimism that there will be sufficient funds available to support programs.
