DRAFT **COMMITTEE MEETING MINUTES** May 24, 2022

A meeting of the Joint Committee on Administrative Rules was scheduled for Tuesday, May 24, 2022, at 9:30 a.m., in the 1200 Room of the Binsfeld Office Building.

The agenda summary is as follows:

- 1. Vote to waive the remaining session days, JCAR 21-69 (MOAHR No. 2020-039 HS) Department of Health and Human Services, Children's Services Agency, Division of Child Welfare Licensing – Child Caring Institutions.
- 2. Vote to waive the remaining session days, JCAR 22-18 (MOAHR No. 2020-70 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing – Board of Nursing – General Rules.
