- Clarify definitions used in the rule set.
- Inform applicants of the requirements pertaining to examinations, licensure by reciprocity, and relicensure.
- Sunset the provisions of a branch facility license because the Occupational Code, 1980 PA 299, MCL 339.101 to 339.2677, does not authorize the department to issue a branch facility license.
