<b>Summary:</b> The purpose of this policy is to provide stability to beneficiaries and families applying for CSHCS coverage or renewal of coverage by removing the requirement that beneficiaries/families be placed in a 90-day Temporary Eligibility Period (TEP), and apply for Medicaid during that time, during the COVID-19 emergency. This policy will also allow medical reports to be submitted by some nurse practitioners and physician assistants for the purpose of CSHCS eligibility and renewal.			
<b>Purpose:</b> To avoid possible loss of CSHCS eligibility for beneficiaries/families who may not be able to apply for Medicaid before the end of a 90-day TEP, and to ensure that families can obtain health care and appropriate medical reports, during the COVID-19 emergency.

(CSHCS) Eligibility and Renewal Requirements

Effective: March 10, 2020

Programs Affected: Children's Special Health Care Services (CSHCS)

Consistent with public health emergency conditions at both the state and federal level related to COVID-19, the Michigan Department of Health and Human Services (MDHHS) is issuing this policy effective March 10, 2020. Given the circumstances, this policy is intended to be time-limited, and MDHHS will notify providers of its termination. This policy announces temporary policy changes regarding eligibility for Children's Special Health Care Services (CSHCS) during the COVID-19 emergency. MDHHS will waive the requirement that beneficiaries/applicants apply for Medicaid and be placed in a 90-day temporary eligibility period (TEP) and will allow some non-physician providers to submit medical reports for CSHCS eligibility.

## **Temporary Eligibility Period (TEP)**

To avoid potential lapse in CSHCS coverage, or delay in CSHCS eligibility during the COVID-19 emergency, MDHHS will waive the requirement that families/beneficiaries/applicants be placed in a 90-day temporary eligibility period when their reported income indicates that they may be eligible for Medicaid. This applies to all beneficiaries/families/applicants who report income on the Income Review/Payment Agreement (MSA-0738) that places them in the lowest payment agreement amount (\$120 per year). During the COVID-19 emergency, all eligibility periods will be issued in 12-month increments. Beneficiaries/applicants will be encouraged, but not required, to apply for Medicaid.

# **Medical Reports for CSHCS Eligibility**

To avoid potential lapse in CSHCS coverage, or delay in CSHCS eligibility during the COVID-19 emergency, MDHHS will allow beneficiaries/applicants to submit medical reports completed and signed by nurse practitioners and physician assistants who work within the medical practice of an approved pediatric subspecialist. These medical reports must contain information regarding eligible diagnosis(es), and severity and chronicity of the diagnosis(es) as outlined in the Children's Special Health Care Services chapter of the MDHHS Medicaid Provider Manual. The MDHHS Medicaid Provider Manual is available on the MDHHS website at <a href="https://www.michigan.gov/medicaidproviders">www.michigan.gov/medicaidproviders</a> >> Policy, Letters & Forms.

All other requirements of CSHCS financial determinations, payment agreements, and medical eligibility as outlined in the Medicaid Provider Manual remain unchanged.
