### Brief description of policy:

To support widespread COVID-19 testing, Medicaid will temporarily reimburse COVID-19 specimen collection when performed by Tribal Health Centers (THCs) and Tribal Federally Qualified Health Centers (FQHCs). In addition, the policy clarifies COVID-19 specimen collection services allowable under MSA 20-57 are not eligible for Medicaid reimbursement if they are provided under another Federal or State of Michigan program or contract.

### Reason for policy (problem being addressed):

Widespread COVID–19 laboratory testing requires significant provider resources to safely collect specimens from many beneficiaries during a pandemic. Reimbursement mechanisms are needed to provide payment for COVID-19 specimen collection services performed in tribal clinics when an eligible qualifying clinic visit is not provided. In addition, billing clarification was needed to prevent dual State and/or Federal reimbursement for specimen collection services.

**Summary:** Recognizing the critical importance of expanding widespread COVID–19 testing and the significant resources involved in safely collecting specimens from many beneficiaries during a pandemic, Medicaid will temporarily reimburse COVID-19 specimen collection services performed by Tribal Health Centers (THCs) and Tribal Federally Qualified Health Centers (FQHCs). In addition, the policy clarifies COVID-19 specimen collection services allowable under MSA 20-57 are not eligible for Medicaid reimbursement if they are provided under another Federal or State of Michigan program or contract.

**Purpose:** To increase and facilitate widespread COVID–19 laboratory testing and to provide billing clarification to prevent dual State and/or Federal reimbursement.

Cost Implications: GF Cost: \$3,000/Fed Cost: \$5,000.

Services provided to American Indians and Alaskan Natives at Tribal 638 facilities are 100% federally matched. The \$5,000 impact represents the federal share for services provided to natives. Tribal 638 facilities also treat non-natives, which explains the \$3,000 general fund impact to the state.

# <u>Tribal Health Centers and Tribal Federally Qualified Health Centers COVID-19 Specimen</u> <u>Collection</u>

Per Centers for Disease Control and Prevention (CDC) and State recommendations, widespread diagnostic testing for COVID–19 is a critical component of a public pandemic response to support infection control and proper treatment. Recognizing the critical importance of expanding this testing and the significant resources involved in safely collecting specimens from many beneficiaries during a pandemic, Medicaid will temporarily reimburse COVID-19 specimen collection services performed by Tribal Health Centers (THC) and Tribal Federally Qualified Health Centers (FQHC).

Consistent with public health emergency conditions at both the state and federal levels related to COVID-19, the Michigan Department of Health and Human Services (MDHHS) is issuing this policy effective March 10, 2020. Given the circumstances, this policy is intended to be time-limited, and MDHHS will notify providers of its termination.

THCs and Tribal FQHCs may bill for COVID-19 collection services for dates of service on or after March 10, 2020 when no other eligible qualifying clinic visit is provided on the same date of service. Services will be excluded from the All-Inclusive Rate reimbursement methodology and reimbursed at a fee screen pursuant to the practitioner payment methodology.

Providers may be reimbursed for COVID-19 specimen collection services using procedure code 99000 (handling and conveyance of specimen for transfer from office to lab) or 99001 (handling and conveyance of specimen for transfer from patient in other than an office to lab) as appropriate. To be eligible for payment, CPT codes 99000 and 99001 must be reported on the institutional claim format with one of the following ICD-10-CM diagnoses:

- Z03.818 Encounter for observation for suspected exposure to other biological agents ruled out (*use for possible exposure to COVID-19*)
- Z11.59 Encounter for screening for other viral diseases (*use for asymptomatic beneficiaries*)
- Z20.828 Contact with and (suspected) exposure to other viral communicable diseases (*use for confirmed exposure to COVID-19*)

All identifiable financial resources must be utilized for COVID-19 specimen collection services provided to Medicaid beneficiaries prior to the use of Medicaid funds. A provider will not be eligible for Medicaid reimbursement if COVID-19 specimen collection services were provided under another Federal or State of Michigan program or contract.

Any COVID-19 specimen collected shall be tested at a laboratory or entity in accordance with federal Clinical Laboratory Improvement Amendments (CLIA) regulations. Proper training for collecting the sample and adherence to the testing device manufacturer's instructions and CDC specimen collection procedures is required. All beneficiaries should be notified of their test results in a timely manner that maintains patient privacy in accordance with state and federal laws and regulations. Providers must comply with any COVID-19 reporting requirements issued by MDHHS.

This policy supplements existing laboratory services policy. All current laboratory ordering and documentation requirements, standards of care, and limitations remain in effect regardless of whether the service is related to COVID-19 testing.

# MSA 20-57 COVID-19 Specimen Collection Clarification

This policy supplements Bulletin MSA 20-57, issued August 11, 2020, and clarifies the billing requirements for COVID-19 specimen collection performed by practitioners, federally qualified health centers (FQHCs) and rural health clinics (RHCs), outpatient hospitals, independent diagnostic laboratories, and pharmacists.

All identifiable financial resources must be utilized for COVID-19 specimen collection services provided to Medicaid beneficiaries prior to the use of Medicaid funds. A provider will not be eligible for Medicaid reimbursement if COVID-19 specimen collection services were provided under another Federal or State of Michigan program or contract.
