The purpose of this bulletin is to inform Medicaid Fee-for-Service (FFS) NEMT authorizing parties of changes to FFS NEMT policy. (Refer to the Michigan Department of Health and Human Services [MDHHS] Medicaid Provider Manual for Medicaid FFS transportation policy.) For services for Medicaid beneficiaries enrolled in a Medicaid Health Plan (MHP), Integrated Care Organization (ICO) or MI Choice Waiver agency, the beneficiary's health plan or waiver agency should be contacted for policy and coverage information.

Transportation Provider Qualifications

All individual and agency transportation providers must adhere to specific qualifications in order to receive Medicaid reimbursement for providing NEMT services. (Refer to the NEMT chapter of the Medicaid Provider Manual for transportation provider qualifications.) Additional transportation provider qualifications will be required by Medicaid FFS policy due to new Medicaid program requirements set by the Consolidated Appropriations Act of 2021. To be authorized to provide and receive reimbursement for NEMT services, a transportation provider who is a beneficiary's family member or foster parent, or a taxicab driver, must not be excluded from participating in any federal health care program, or listed on the MDHHS sanctioned provider list or the U.S. Department of Health and Human Services (HHS) exclusion list. The provider also must not have been convicted under a federal or state law after August 21, 1996, for a felony criminal offense relating to the unlawful manufacture, distribution, prescription, or dispensing of a controlled substance. The provider will report any felony conviction relating to a controlled substance and traffic violations.
