JCAR 21-61 (MOAHR No. 2020-111 LR) Department of Licensing and Regulatory Affairs, Physical Therapy - General Rules. These rules were submitted to JCAR on October 20, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-62 (MOAHR No. 2019-059 LR) Department of Licensing and Regulatory Affairs, Gas Safety. These rules were submitted to JCAR on October 20, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-63 (MOAHR No. 2019-084 LR) Department of Licensing and Regulatory Affairs, Chiropractic - General Rules. These rules were submitted to JCAR on October 20, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-64 (MOAHR No. 2020-128 LR) Department of Licensing and Regulatory Affairs, Pharmacy - General Rules. These rules were submitted to JCAR on October 21, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-74 (MOAHR No. 2021-062 ST) Department of State, Bureau of Elections - Online Absent Voter Ballot Application. These rules were submitted to JCAR on December 8, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-75 (MOAHR No. 2021-041 LR) Department of Licensing and Regulatory Affairs, Public Service Commission - Unbundled Network Element and Local Interconnection Services. These rules were submitted to JCAR on December 9, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 21-76 (MOAHR No. 2021-056 LR) Department of Licensing and Regulatory Affairs, Public Service Commission - Basic Local Exchange Service Customer Migration. These rules were submitted to JCAR on December 15, 2021. The last day for JCAR consideration is 15 session days from submission.

JCAR 22-05 (MOAHR No. 2020-124 LR) Department of Licensing and Regulatory Affairs, Marihuana Regulatory Agency - Marihuana Sampling and Testing. These rules were submitted to JCAR on January 5, 2022. The last day for JCAR consideration is 15 session days from submission.

JCAR 22-06 (MOAHR No. 2021-010 LR) Department of Licensing and Regulatory Affairs, Marihuana Regulatory Agency – Marihuana Employees. These rules were submitted to JCAR on January 5, 2022. The last day for JCAR consideration is 15 session days from submission.

JCAR 22-07 (MOAHR No. 2021-029 LR) Department of Licensing and Regulatory Affairs, Marihuana Regulatory Agency – Marihuana Declaratory Rulings. These rules were submitted to JCAR on January 5, 2022. The last day for JCAR consideration is 15 session days from submission.

JCAR 22-08 (MOAHR No. 2020-119 LR) Department of Licensing and Regulatory Affairs, Marihuana Regulatory Agency – Marihuana-Infused Products and Edible Marihuana Product. These rules were submitted to JCAR on January 5, 2022. The last day for JCAR consideration is 15 session days from submission.

JCAR 22-09 (MOAHR No. 2020-122 LR) Department of Licensing and Regulatory Affairs, Marihuana Regulatory Agency – Marihuana Operations. These rules were submitted to JCAR on January 5, 2022. The last day for JCAR consideration is 15 session days from submission.

JCAR 22-10 (MOAHR No. 2021-069 AC) Department of Agriculture and Rural Development, Pesticide and Plant Pest Management Division – Regulation No. 634. Commercial Fertilizers. These rules were submitted to JCAR on January 5, 2022. The last day for JCAR consideration is 15 session days from submission.

JCAR 22-11 (MOAHR No. 2021-020 LR) Department of Licensing and Regulatory Affairs, Director's Office, Professional Engineers – General Rules. These rules were submitted to JCAR on January 18, 2022. The last day for JCAR consideration is 15 session days from submission.

How to Determine the Number of Session Days Left for JCAR Review of Rules**

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then.
A session day is defined in MCL 24.245a(13) as a day in

which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.

Below is our list of days this session* on which both houses have convened and recorded a quorum. Please note that this is not an official list. We have done our best to prepare an accurate list, and we will attempt to update it regularly. If you see any mistakes, please let us know.
