**JCAR 22-23 (MOAHR No. 2021-071 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Massage Therapy - General Rules. These rules were submitted to JCAR on May 13, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-24 (MOAHR No. 2021-038 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Acupuncture - General Rules. These rules were submitted to JCAR on May 16, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-25 (MOAHR No. 2021-046 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Accountancy - General Rules. These rules were submitted to JCAR on May 16, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-26 (MOAHR No. 2021-081 LR)** Department Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Nurse Aide, Nurse Aide Trainer, and Nurse Aide Training Program, Certificate of Registration and Permit Program. These rules were submitted to JCAR on May 26, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-27 (MOAHR No. 2020-129 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Board of Midwifery. These rules were submitted to JCAR on July 25, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-28 (MOAHR No. 2021-054 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Osteopathic Medicine and Surgery - General Rules. These rules were submitted to JCAR on July 28, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-29 (MOAHR No. 2020-131 LR)** Department of Licensing and Regulatory Affairs, Corporations, Securities, and Commercial Licensing - Unarmed Combat. These rules were submitted to JCAR on July 28, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-30 (MOAHR No. 2021-003 LR)** Department of Licensing and Regulatory Affairs, Public Service Commission - Consumer Standards and Billing Practices for Electric and Natural Gas Service. These rules were submitted to JCAR on July 28, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-31 (MOAHR No. 2021-076 LR)** Department of Licensing and Regulatory Affairs, Public Service Commission - Service Quality and Reliability Standards for Electric Distribution Systems. These rules were submitted to JCAR on July 28, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-32 (MOAHR No. 2021-077 LR)** Department of Licensing and Regulatory Affairs, Public Service Commission - Technical Standards for Electric Service. These rules were submitted to JCAR on July 28, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-33 (MOAHR No. 2019-138 LR)** Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Elevators. These rules were submitted to JCAR on July 29, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-34 (MOAHR No. 2021-057 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Veterinary Medicine - General Rules. These rules were submitted to JCAR on August 5, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-35 (MOAHR No. 2022-010 AC)** Department of Agriculture and Rural Development, Pesticide and Plant Pest Management Division - Regulation No. 623. Field Seed Certification. These rules were submitted to JCAR on September 19, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-36 (MOAHR No. 2021-096 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Respiratory Care - General Rules. These rules were submitted to JCAR on September 19, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-37 (MOAHR No. 2021-070 LE)** Department of Labor and Economic Opportunity, State Housing Development Authority - General Rules. These rules were submitted to JCAR on September 28, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-38 (MOAHR No. 2021-095 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Podiatric Medicine and Surgery - General Rules. These rules were submitted to JCAR on October 19, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-39 (MOAHR No. 2022-017 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Public Health Code - General Rules. These rules were submitted to JCAR on October 19, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-40 (MOAHR No. 2021-078 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Athletic Trainers - General Rules. These rules were submitted to JCAR on October 26, 2022. The last day for JCAR consideration is 15 session days from submission.

**JCAR 22-41 (MOAHR No. 2022-011 NR)** Department of Natural Resources, Wildlife Division - Endangered and Threatened Species. These rules were submitted to JCAR on November 1, 2022. The last session day for JCAR consideration is 15 session days from submission.

**JCAR 22-42 (MOAHR No. 2021-044 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Medicine - General Rules. These rules were submitted to JCAR on November 1, 2022. The last session day for JCAR consideration is 15 session days from submission.

**How to Determine the Number of Session Days Left for JCAR Review of Rules\*\***

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.
