

Rules Before JCAR as of October 27, 2023**

JCAR 23-75 (MOAHR No. 2023-002 HS) Department of Health and Human Services, Bureau of Emergency Preparedness, EMS, and Systems of Care Section - Statewide Stroke System. These rules were submitted to JCAR on September 21, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-76 (MOAHR No. 2021-075 NR) Department of Natural Resources, Forest Resource Division - Commercial Forests. These rules were submitted to JCAR on September 21, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-77 (MOAHR No. 2023-019 LR) Department of Licensing and Regulatory Affairs, Public Service Commission - Gas Safety. These rules were submitted to JCAR on September 25, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-78 (MOAHR No. 2022-037 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Marriage and Family Therapy - General Rules. These rules were submitted to JCAR on October 3, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-79 (MOAHR No. 2022-061 HS) Department of Health and Human Services, Public Health Administration - Statewide ST-Elevation Myocardial Infarction (STEMI) System. These rules were submitted to JCAR on October 16, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-80 (MOAHR No. 2023-029 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Genetic Counseling - General Rules. These rules were submitted to JCAR on October 18, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-81 (MOAHR No. 2022-056 LR) Department of Licensing and Regulatory Affairs, Bureau of Construction Codes- Construction Code - Part 7. Plumbing Code. These rules were submitted to JCAR on October 18, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-82 (MOAHR No. 2022-059 LR) Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Construction

Code - Part 8. Electrical Code. These rules were submitted to JCAR on October 19, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-83 (MOAHR No. 2022-055 LR) Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Construction Code - Part 9A. Mechanical Code. These rules were submitted to JCAR on October 19, 2023. The last day for JCAR consideration is 15 session days from submission.

JCAR 23-84 (MOAHR No. 2023-028 LR) Department of Licensing and Regulatory Affairs, Public Service Commission - Responsibilities of Providers of Basic Local Exchange Service that Cease to Provide the Service. These rules were submitted to JCAR on October 24, 2023. The last day for JCAR consideration is 15 session days from submission.

How to Determine the Number of Session Days Left for JCAR Review of Rules**

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.

Below is our list of days this session* on which both houses have convened and recorded a quorum. Please note that this is not an official list. We have done our best to prepare an accurate list, and we will attempt to update it regularly. If you see any mistakes, please let us know.
