

**Rules Before JCAR as of February 26, 2024\*\***

**JCAR 23-85 (MOAHR No. 2022-008 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Pharmacy - General Rules. These rules were submitted to JCAR on October 31, 2023. The last day for JCAR consideration is 15 session days from submission.

**JCAR 23-86 (MOAHR No. 2023-006 NR)** Department of Natural Resources, Law Enforcement Division - State Land Use Rules. These rules were submitted to JCAR on November 20, 2023. The last day for JCAR consideration is 15 session days from submission.

**JCAR 23-87 (MOAHR No. 2023-008 LE)** Department of Labor and Economic Opportunity, MIOSHA - Ionizing Radiation Rules Governing the Use of Radiation Machines. These rules were submitted to JCAR on November 30, 2023. The last day for JCAR consideration is 15 session days from submission.

**JCAR 23-88 (MOAHR No. 2023-034 LE)** Department of Labor and Economic Opportunity, Michigan Rehabilitative Services - Vocational Rehabilitation. These rules were submitted to JCAR on November 30, 2023. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-01 (MOAHR No. 2023-030 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Medicine - General Rules. These rules were submitted to JCAR on January 10, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-02 (MOAHR No. 2021-099 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Carnival and Amusement Safety, General Rules. These rules were submitted to JCAR on January 17, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-03 (MOAHR No. 2023-021 IF)** Department of Insurance and Financial Services, Insurance - Holding Companies. These rules were submitted to JCAR on January 18, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-04 (MOAHR No. 2022-024 HS)** Department of Health and Human Services, Bureau of Epidemiology - Mandatory Reporting of

Chronic Diseases. These rules were submitted to JCAR on February 12, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-05 (MOAHR No. 2022-036 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing – Board of Nursing – General Rules. These rules were submitted to JCAR on February 22, 2024. The last day for JCAR consideration is 15 session days from submission.

### **How to Determine the Number of Session Days Left for JCAR Review of Rules\*\***

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.

Below is our list of days this session\* on which both houses have convened and recorded a quorum. Please note that this is not an official list. We have done our best to prepare an accurate list, and we will attempt to update it regularly. If you see any mistakes, please let us know.
