The Chair called the meeting to order at 9:16 a.m. He instructed the Clerk to call the roll. At that time, the following members were present: Chair Wojno, Sen(s). Bayer, McMorrow, Theis and Runestad, Alternate Chair Haadsma, Rep.(s) Libarati, Bierlein and Beeler, a quorum was present.
