**IX. Review of Subcommittee Assignments**

**X. Review of Mental Health Services for Incarcerated Individuals Ad Hoc Committee Assignments.**

The Chair directed attention to the Ad Hoc committee roster. Dr. Kapenga expressed interest in serving as Chair of the Ad Hoc committee. Ms. Schroeder and Ms. Straube expressed interest in serving as Ad Hoc members.

Dr. Kapenga expressed a need for tribal representation. Sheriff Main noted communication in his area with tribal communities. The Chair noted subcommittee Chairs and the Ad Hoc Chair must be a current member of the Committee and would encourage tribal representation serving as a subcommittee member.

Dr. Kapenga inquired on renaming subcommittees. The Chair expressed interest in entertaining renaming subcommittees during next meeting. Judge Voet noted to check with proper procedures involving renaming subcommittees to confirm the Committee has the authority.

**XI. Funding Update**

The Chair called on Mr. Smith for an update. Mr. Smith updated the grant application process will begin on April 1. Mr. Smith noted in looking at the levels of funding it appears it will be similar to what was funded to courts last year. Mr. Smith reported there are issues with some courts underspending their funds and note this year will begin a new reallocation process. Mr. Smith updated funds will be pulled back from courts where there is underspending unless acceptable reason for the underspending is provided, taking note there are some things that will be taken into consideration. Mr. Smith noted next year anticipate OHSP funding will be expanded for existing courts rather than just new courts.

Ms. Day inquired if funds will be available to courts for recovery coaches. Mr. Smith noted there has been growth in those criteria and it is an allowable expense.

The Chair expressed appreciation for Mr. Smith's update on the reallocation process.

Ms. Straube inquired what other funds can be used to offset the difference in lodging as currently is set at a \$85 per night rate for conference lodging. Mr. Smith noted limiting to the state rate of \$85 per night and confirmed can use general funds to offset costs but unsure of other grant dollars as some grants are limited. Mr. Smith noted the lodging rate has been set forth by DTMB.

Judge McGinnis inquired on the timing of reallocation with the application deadline. Mr. Smith encourages to put anticipated needs in the grant application also noting looking at reallocation requests in April. Mr. Smith noted the turnaround time for reallocation is believed to be in May.

**XII. Approval of SDTCAC 2022-2023 Annual Report**

The Chair directed attention to the proposed 2022-2023 Annual Report and asked if there were any changes. There were none. **Dr. Kapenga moved, supported by Ms. Straube to approve the 2022-2023 State Drug Treatment Court Advisory Committee Annual Report. There was no further discussion and the Chair asked for a roll call vote. The motion prevailed.**

The Chair noted the 2022-2023 State Drug Treatment Court Advisory Committee Annual Report will be distributed to the members of the Michigan Legislature and the Michigan Supreme Court as required by statute.

**XIII. Committee Meeting Dates**

The Chair noted Committee meetings have been held quarterly and on a Tuesday morning. The Chair opened for discussion on future Committee meeting dates noting in the interest of ensuring the Committee has quorum for each meeting. Following discussion, the Committee agreed upon a 10:00 a.m. meeting time for July 9, 2024, October 8, 2024, January 7, 2025, and April 8, 2025.

**XIV. Committee Member Comment**

The Chair asked if there were any additional comments from the Committee members.

Dr. Kapenga expressed concern as an MOUD provider that there is a significant change in Medicaid reimbursement for those who receive services with the redetermination process. During COVID, they did not have the annual eligibility rule because they did not want to dismiss anyone. They started the redetermination process for eligibility last year. There are 3 million cases noting people losing their Medicaid coverage. Dr. Kapenga noted that the process is not user-friendly. Secondly, as of January 1st, MDHHS has carved out services for medical health plans noting essentially reimbursements for providers are being delayed because they are in one agency and having to enroll in another agency for payment.

Mr. Wallace noted the Department of Justice is suing some states and some courts for rejecting participants on MOUD under the Americans with Disabilities Act. Mr. Wallace expressed a need to keep a closer eye on this issue.

Sheriff Main expressed similar on-going issues in treatment for inmates.

Ms. Schroeder expressed concern with the delay of mental health treatment in county jails as well as individuals waiting months for an evaluation.

The Chair asked if there were any comments from the public. There was none.
