The purpose of this policy is to provide updated information regarding bulletin MMP 23-74 - Medicaid Coverage of Community Health Worker (CHW)/Community Health Representative (CHR) Services and clarification specific to specialty behavioral health providers.

CHW services covered under MMP 23-74 will be included in the behavioral health service list and reimbursable through Prepaid Inpatient Health Plans (PIHPs) effective for dates of service on or after October 1, 2024.

General Information

CHWs have an important role promoting health outcomes related to both physical and behavioral health. While MMP 23-74 did not explicitly include CHW services in the Behavioral Health Code Chart, this clarification provides an update to allow behavioral health providers to seek reimbursement for CHW services. CHWs can be utilized by specialty behavioral health providers to facilitate access to needed health and social services as outlined in MMP 23-74.

Covered Services

Covered services remain the same as outlined in MMP 23-74.

Peer Support Specialist (PSS) and Peer Recovery Coach (PRC) services are separately covered under bulletins MSA 21-38 and HASA 22-01, respectively. To seek Medicaid reimbursement for the delivery of CHW services, an individual must meet the requirements outlined in MMP 23-74. All other policy requirements for coverage of CHW services outlined in MMP 23-74 remain unchanged.
