3 MS. BRENNAN: Good morning. It is now 9:09 a.m.
4 It is Tuesday, October 12th, 2021. We are on the record for
5 the first of two hearings for rule set 2020-02 HS, Child
6 Placing Agencies. My name is Mary Brennan. I am from the
7 DHHS Bureau of Legal Affairs and the Regulatory Affairs
8 Officer for the Department. To my left I would like to
9 introduce our subject matter experts for the hearing,
10 starting with Ms. Angie. Angie, introduce yourself and
11 please state your position with DHHS.

12 MS. HULL: Angela Hull, program manager in the
13 Division of Child Welfare Licensing.

14 MS. BRENNAN: Thank you. Our other expert is Ms.
15 Jessica. Jessica, same?

16 MS. VANDENHEUVEL: Jessica VandenHeuvel, DCWL area
17 manager.

18 MS. BRENNAN: Thank you. Okay. Housekeeping
19 before we begin. The hearing will be recorded for the
20 purposes of transcription and transparency. Please approach
21 the podium if you would like to make a statement. Provide
22 your name, spell last name for the transcriptionist -- oh, I
23 forgot to introduce Ms. Marcy is our transcriptionist for
24 today -- and any organization you may be speaking on behalf
25 of, then provide your comment. One person at a time. While

1 your comments are invaluable to the public hearing, we ask
2 that you respect the public hearing process, please keep
3 comments respectable and not disrupt the hearing process for
4 all. This is a state building and we are required to wear
5 masks at all times to protect the public. Please follow
6 this mandate during your time in the building.

7 There will be two 15-minute breaks, one at 10:00
8 o'clock and one at 2:00 o'clock p.m., and one 45-minute
9 break at 12:00 o'clock noon. Restrooms, down the hall to
10 your right. Snack shop at the end of the hall to your
11 right. Right now they're currently offering packaged
12 snacks, popcorn, coffee, and bottled drinks. For lunch,
13 head straight down to Washington one block down and there
14 will be a variety of restaurants, coffee shops as well.

1 MS. BRENNAN: Please wait two weeks before
2 requesting a comment (sic). Any questions before we start
3 taking public comment? Okay. The microphone is open for
4 public comment. Please approach if you would like to make a
5 comment at today's hearing.

6 LARA BOUSE

7 MS. LARA BOUSE: Good morning. Lara Bouse,
8 B-o-u-s-e, Fostering Forward Michigan. Having worked in
9 conjunction with the Department in reviewing these rules and
10 reviewing them as intended today, I have three comments I'd
11 like to make or three rules I'd like to comment on.

12 The first one is 400.12328(1) on the Foster Home
13 Record. We would like to strike the word "electronic" as it
14 provides a barrier to non-contracted agencies to doing this
15 important work. We would like to have language that
16 suggests keeping the record in a manner as prescribed by the
17 Department instead. Rule 12 -- 400.12713 Adoption
18 Placement, we would like language added to maintain records
19 for all adoptions, not just those for children of the Child
20 Welfare System under DHHS. Rule 400.12403(3), we are
21 adamant that this language needs to remain and shall not be
22 changed. Not having this language has proven to reduce --
23 is proven to increase barriers. This language reduces
24 barriers for cooperation in cross agency placements now
25 known as borrowed beds, and allows foster homes more

1 confidence in being able to do the same job consistently no
2 matter what agency they're working with.

3 And that's it. Otherwise, we're in full agreement
4 with the rules as intended.

5 MS. BRENNAN: Thank you very much. Marcy, off the
6 record, please. 115627
