**4. Summary of proposed rules:**

<p>R 338.7201. This rule pertains to definitions. It sets forth an explanation of specific terms used throughout the rule set. Clarification of some of the terms used in the rule set have been made.</p> <p>R 338.7202. This rule pertains to identifying human trafficking. It sets forth the requirements for training on human trafficking. The proposed human trafficking rule indicates the renewal cycle year when applicants for license renewal will have to obtain the training as well as the date after which applicants for initial licensure will have to obtain the training. The current rule doesn't specify information when this training must be obtained. The proposed rule will provide notice to applicants for initial licensure and license renewal of the timelines for obtaining the required training.</p> <p>R 338.7203. This rule pertains to educational limited licenses. It sets forth the requirements that must be met to qualify for an educational limited license. Statutory references have been added to point to the applicable provisions under the public health code. A clarification has been added that the educational limited license may not be renewed more than 5 times.</p> <p>R 338.7205. This rule pertains to licensure. It sets forth the requirements that must be met to qualify for licensure. Statutory references have been added to point to the applicable provisions under the public health code. A typographical revision has been made to the abbreviation for the association of marital and family therapy regulatory boards (AMFTRB).</p>

R 338.7207. This rule pertains to examination eligibility. It sets forth the requirements that must be met to sit for the national examination in marital and family therapy. A rule reference has been added to point to the required examination that is adopted in the rules.

R 338.7209. This rule pertains to examination adoption. It sets forth the required examination that the board adopts for licensure. Typographical revisions have been made to shorten references to the AMFTRB.

R 338.7211. This rule pertains to educational standards. It sets forth the requirements that must be met for accredited programs. This rule will be amended to provide updated accreditation standards for marriage and family therapists educational programs, which are adopted by reference.

R 338.7213. This rule pertains to licensure by endorsement. It sets forth the requirements that must be met for licensure by this method. Statutory references have been added to point to the applicable provisions under the public health code.

R 338.7215. This rule pertains to relicensure. It sets forth the requirements that must be met to qualify for relicensure. This rule will be amended to clarify additional requirements that applicants must provide, including fingerprints and establishing good moral character.

R 338.7219. This rule pertains to license renewal. It sets forth the requirements that must be met to qualify for license renewal. The requirement that applicants must complete renewal of their license on a form provided by the department has been added, as well as a reference to the code that explains the circumstances surrounding a renewal application that is submitted within 60-days after the expiration date.




