4 MS. DITSCHMAN: Good morning. My name is
5 Andria Ditschman, and I am an analyst for the Bureau of
6 Professional Licensing in the Department of Licensing and
7 Regulatory Affairs. I'll be conducting the hearing
8 today.

9 This is a public hearing on the proposed
10 administrative rules entitled "Occupational Code
11 Renewals" and "Pharmacy - Animal Euthanasia and Sedation
12 Rules". We are conducting the hearing as required by the
13 Administrative Procedures Act to allow the public to
14 comment on the proposed changes to these rule sets. As
15 with all other public hearings on draft rule sets, the
16 only items discussed during this hearing will be the
17 proposed changes to these rule sets. The hearing will
18 not be covering any questions or discussions on any other
19 issues.

20 We're calling this hearing to order at
21 9:01 a.m. on July 2, 2021, via Zoom to comply with
22 Lansing City Council Resolution 2020-81 and statutorily
23 required measures designed to help prevent the spread
24 Coronavirus 2019, known as COVID-19. The notice of
25 public hearing was published in three newspapers of

1 general circulation, the Flint Journal and the Grand
2 Rapids Press on June 17, 2021, and the Mining Journal on
3 June 16, 2021, as well as the *Michigan Register*, Issue
4 #11-2021, published on July 1, 2021.

5 All comments should relate directly to
6 the proposed rules. If you have questions about the
7 rules, you may place your comments on the record and the
8 Department will review and consider them. If you have
9 suggested changes to the proposed rules, please include
10 the specific reasons why the changes would be in the
11 public interest.

12 We will take comments in the following
13 manner.

- 14 • For those using the Video Conference Portion
15 (those not calling on the telephone), please use
16 the "Raise Your Hand" feature in Zoom. I will
17 call on individuals to speak and they will be
18 unmuted at that time.
- 19 • For participants that are available only by
20 telephone, we will ask if you wish to make a
21 comment after the video participants have
22 finished.
- 23 • If you have a comment but do not wish to speak,

3 If you have previously submitted comments
4 in writing to the Bureau, it is not necessary for you to
5 repeat your comments on the record today. Comments made
6 in writing will be reviewed and considered by the
7 Department in the same manner as comments made during
8 this public hearing.

9 Those making comments during this hearing
10 should clearly and slowly say and spell your name and
11 advise if you are speaking on behalf of an organization.
12 We will limit comments to three minutes per person.
13 Please remember that only one person should speak at a
14 time.

15 The Department staff from the Bureau of
16 Professional Licensing with me today includes Dena Marks,
17 LeAnn Payne, and Kerry Przybylo.
