The hearing is held to receive public comments on the following administrative rules:

Medicine – General Rules (MOAHR # 2024-64 LR)

Authority: MCL 333.16145, MCL 333.16148, MCL 333.16174, MCL 333.16204, MGL 333.16215, MCL 333.16287, MCL 333.17031, MCL 333.17033, MCL 333.17048, and MCL 333.17076, and Executive Reorganization Order Nos. 1991-9, 1996-2, 2003-1, and 2011-4, MCL 338.3501, MCL 445.2001, MCL 445.2011, and MCL 445.2030.

Overview: The proposed revisions include updates to accreditation standards, clarifying language, grammatical edits to comply with current drafting standards, and clarification of proof requirements for successful completion of a physician re-entry program.

> Sanitarians – General Rules (MOAHR #2024-60 LB)

Authority: MCL 333, 16145, MCL 333, 16148, and MCL 333, 18413, and Executive Reorganization Nos. 1991-9, 1996-2, 2003-1, 2009-10, and 2011-4, MCL 338, 3501, MCL 445, 2001, MCL 445, 2011, MCL 333, 26364, and MCL 445, 2030.

Overview: The proposed revisions include updates to environmental health baccalaureate program accreditation standards and environmental health graduate program accreditation standards, grammatical edits to comply with current drafting standards, expansion of the period In which an applicant may pass the examination for reregistration, and removal of the reference to the two-year registration cycle.

The rules will take effect immediately upon filing wilh the Secretary of State, unless specified otherwise in the rules. Comments on the proposed rules may be presented in person at the public hearing.
