Overview: The proposed revisions to the rules include the most current standards of professional practice, supply the cost for obtaining copies of the adopted standards, and Carity the coursework requirements for a concentration in accounting

#### Task Force on Physicians Assistants - General Rules (MOAHR #2024-53 LR)

Authority: MCL 333.16145, MCL 333.16148, MCL 333.17060, and MCL 333,17058 and Executive Reorganization Nos, 1991-9, 1996-2, 2003-1 and 2011-4, MCL 338.3501, 445.2001, 445.2011, and 445.2030.
