



Current issues have evolved that require a review of the entire rule set to address LGBTQ youth, restraints, seclusion, and behavior management. Further, there are conflicts within the child caring institution, child placing agencies, and foster family and group home rules that need to be amended for consistency for the contracted agencies providing services. All three rule sets are currently being revised.

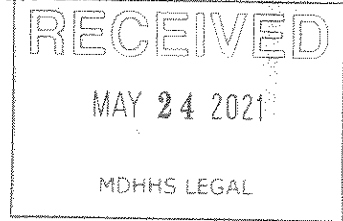

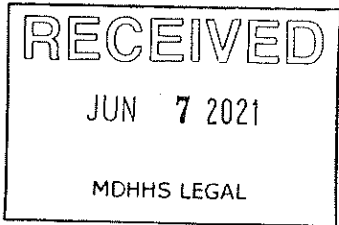
