

### Just Believe events coming up

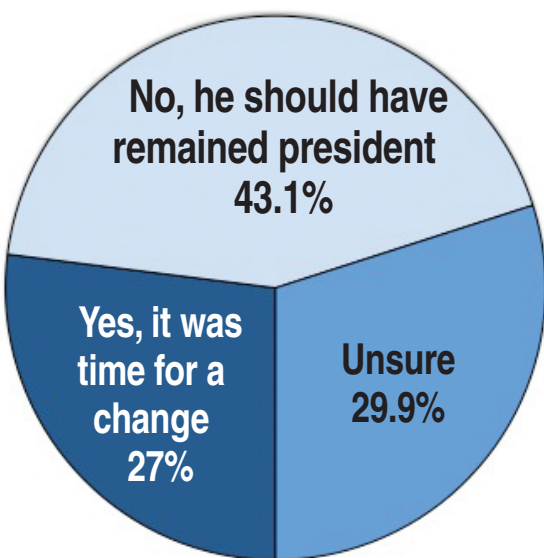
GWINN — The Just Believe 2021 Bike/Walk/Run is set for Sunday at The Up North Lodge in Gwin.
