7                   Weston MacIntosh, and I am a Departmental Specialist for  
8                   the Bureau of Professional Licensing in the Department of  
9                   Licensing and Regulatory Affairs, and I will be  
10                  conducting the hearing today.

11                  This is a public hearing on proposed  
12                  administrative rules entitled "Audiology - General  
13                  Rules", "Centralized Prescription Processing Pharmacies",  
14                  "Chiropractic - General Rules", "Counseling - General  
15                  Rules", and "Physical Therapy - General Rules". We are  
16                  conducting this hearing under the authority of the  
17                  Administrative Procedures Act, Public Act 306 of 1969, on  
18                  behalf of the Department of Licensing and Regulatory  
19                  Affairs, Bureau of Professional Licensing.

20                  We are calling this hearing to order at  
21                  9:00 o'clock a.m. on December 14, 2022, at the G. Mennen  
22                  Williams Building Auditorium, 525 West Ottawa Street,  
23                  Lansing, Michigan. Publication of the notice of public  
24                  hearing was in three newspapers of general circulation,  
25                  including the Flint Journal on November 10, 2022; the

1 Grand Rapids Press on November 10, 2022; the Mining  
2 Journal on November 23, 2022; as well as the *Michigan*  
3 *Register, Issue #21*, published on December 1, 2022.

4 We are here today to receive your  
5 comments on proposed rules. If you wish to speak, please

25 This will help the Department prepare the hearing record

1 that will go before the Boards. You can give written  
2 statements directly to me at the table. The Department  
3 will also accept written statements emailed or postmarked  
4 until 5:00 o'clock p.m. today.

5 The Department staff from the Bureau of  
6 Professional Licensing also includes Stephanie Wysack.
