JCAR 25-44 (MOAHR No. 2023-015 EQ) Department of Environment, Great Lakes, and Energy, Air Quality Division - Part 10. Intermittent Testing and Sampling. These rules were submitted to JCAR on May 20, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-45 (MOAHR No. 2022-064 ST) Department of State, Elections and Campaign Finance - Electronic Return of Absent Voter Ballots by Eligible Voters. These rules were submitted to JCAR on May 21, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-46 (MOAHR No. 2024-060 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Sanitarians Registration - General Rules. These rules were submitted to JCAR on June 3, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-47 (MOAHR No. 2024-054 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Accountancy - General Rules. These rules were submitted to JCAR on June 10, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-48 (MOAHR No. 2023-031 LR) Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Licensed Midwifery. These rules were submitted to JCAR on June 17, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-49 (MOAHR No. 2025-014 ST) Department of State, Bureau of Elections - Use of Electronic Pollbook. These rules were submitted to JCAR on July 28, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-50 (MOAHR No. 2024-052 EQ) Department of Environment, Great Lakes, and Energy, Water Resources Division - Sewerage Systems. These rules were submitted to JCAR on July 30, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-51 (MOAHR No. 2023-065 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems -

Adult Foster Care Family Homes. These rules were submitted to JCAR on August 19, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-52 (MOAHR No. 2023-066 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Adult Foster Care Congregate Facilities. These rules were submitted to JCAR on August 26, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-53 (MOAHR No. 2023-067 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Adult Foster Care Large Group Homes. These rules were submitted to JCAR on August 26, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-54 (MOAHR No. 2023-068 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Adult Foster Care Small Group Homes. These rules were submitted to JCAR on August 26, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-55 (MOAHR No. 2023-069 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Adult Foster Care Facilities. These rules were submitted to JCAR on August 26, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-56 (MOAHR No. 2023-071 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Licensing Adult Foster Care Facilities. These rules were submitted to JCAR on September 2, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-57 (MOAHR No. 2025-006 ST) Department of State, Vehicles and Watercraft - Michigan Personalized Plate Rules. These rules were submitted to JCAR on September 2, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-58 (MOAHR No. 2023-070 LR) Department of Licensing and Regulatory Affairs, Bureau of Community and Health Systems - Certification of Specialized Programs. These rules were submitted to JCAR on September 3, 2025. The last day for JCAR consideration is 15 session days from submission.

JCAR 25-59 (MOAHR No. 2023-080 LR) Department of Licensing and Regulatory Affairs, Corporations, Securities, and Commercial

Licensing - Private Security Guard and Security Alarm Agencies. These rules were submitted to JCAR on September 4, 2025. The last day for JCAR consideration is 15 session days from submission.

How to Determine the Number of Session Days Left for JCAR Review of Rules**

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.

Below is our list of days this session* on which both houses have convened and recorded a quorum. Please note that this is not an official list. We have done our best to prepare an accurate list, and we will attempt to update it regularly. If you see any mistakes, please let us know.
