

**Rules Before JCAR as of May 31, 2024\*\***

**JCAR 24-08 (MOAHR No. 2023-033 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Acupuncture - General Rules. These rules were submitted to JCAR on April 15, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-09 (MOAHR No. 2023-062 IF)** Department of Insurance and Financial Services, Insurance - Surplus Lines Insurance Fees. These rules were submitted to JCAR on April 17, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-10 (MOAHR No. 2023-044 IF)** Department of Insurance and Financial Services, Financial Institutions - Debt Management. These rules were submitted to JCAR on May 1, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-11 (MOAHR No. 2023-077 ED)** Department of Education, Superintendent of Public Instruction - Teacher and School Administrator Evaluation Tools. These rules were submitted to JCAR on May 13, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-12 (MOAHR No. 2023-079 ED)** Department of Education, Superintendent of Public Instruction - Teacher Certification Code. These rules were submitted to JCAR on May 15, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-13 (MOAHR No. 2022-057 LR)** Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Construction Code - Part 4. Building Code. These rules were submitted to JCAR on May 21, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-14 (MOAHR No. 2022-058 LR)** Department of Licensing and Regulatory Affairs, Bureau of Construction Codes - Rehabilitation Code. These rules were submitted to JCAR on May 21, 2024. The last day for JCAR consideration is 15 session days from submission.

**JCAR 24-15 (MOAHR No. 2023-037 LR)** Department of Licensing and Regulatory Affairs, Bureau of Professional Licensing - Audiology - General Rules. These rules were submitted to JCAR on May 28,

2024. The last day for JCAR consideration is 15 session days from submission.

### **How to Determine the Number of Session Days Left for JCAR Review of Rules\*\***

Under MCL 24.245a, the Joint Committee on Administrative Rules generally has 15 session days to act on a set of rules submitted to the committee. To determine when that time will expire for a set of rules that you are interested in, do the following:

1. Determine the date the rules were submitted to JCAR.
2. Determine how many session days there have been since then. A session day is defined in MCL 24.245a(13) as a day in which both houses of the legislature convene and record a quorum. You can determine this yourself by checking the journals here:

If 15 session days have passed and JCAR has not taken up the rules, the rules are probably no longer before JCAR, and have been or will soon be submitted to the Secretary of State and take effect.

Please note that under MCL 24.245a(12), a rule pending before the committee at the final adjournment of a regular session held in an even-numbered year must be withdrawn and resubmitted to the committee during the next session, at which point a new and untolled 15-session-day period begins.

Below is our list of days this session\* on which both houses have convened and recorded a quorum. Please note that this is not an official list. We have done our best to prepare an accurate list, and we will attempt to update it regularly. If you see any mistakes, please let us know.
